### **Owner's Manual**

Thank you for purchasing a REFRIGERATOR /FREEZER THERMOMETER. Please read this entire guide carefully and keep it for future reference. This thermometer is intended to help identify the improper setting and/or function of a refrigerator or freezer. Never consume food or beverages that you suspect have spoiled.

**Before Use:** When not in use, the liquid in the thermometer may run into the expansion chamber. Before use, hold the thermometer firmly, with the bulb end down. Shake the thermometer until all liquid is out of the top chamber and forms a solid column down to the bulb.

If at any time you suspect this product is damaged, DO NOT USE. If cracked or broken, immediately discard the thermometer. Keep away from children, pets and individuals with impaired cognitive abilities.

If you have any questions or would like to request warranty service, please contact the distributor from whom you purchased the thermometer.
