Definitions

The Direct Supply Panacea FlexEze Contracture Elbow Brace ("Device") is distributed by Direct Supply Manufacturing, Inc., referred to throughout this manual as "We," "Us" or "Our." "You" refers to the facility, community or other entity that has purchased the device.

Read and follow all directions and warnings before using this device. Do not use this device without first reading and understanding this user manual. Damage, injury or even death may result from improper use of this device or not following directions and warnings. This device is intended for use by or under the supervision of trained and licensed healthcare or senior care providers in normal, indoor conditions.

WARNING: Immediately discontinue device use and contact appropriate healthcare personnel for further instructions if the device user experiences any of the following while using the device:

Device Description

The Direct Supply Panacea FlexEze Contracture Elbow (Model # DS-ECE) is a prefabricated brace specifically designed to help treat and correct elbow flexion contractures. This unique design can be applied from the lateral side of the arm and the brace may be used for mild, moderate and severe contractures. The dynamic properties of the Direct Supply Panacea Contracture Elbow present a low-load prolonged stretch to the contracted joint. There are no metal hard goods, making it comfortable for night use. The device includes a goniometer hinge that may be set for flexion or extension control. The device comes with a mesh laundry bag.

Directions for Use

To apply the device: Place the device from the lateral side of the arm with the brace folded in the cubital crease. Fasten the bicep and forearm. Position the elbow cap over the elbow. Extend the arm to end range and tighten the elbow straps on each side. This application provides a dynamic treatment. The dynamic properties help prevent the elbow from flexing and may make the device more comfortable for night wear.

To apply goniometer hinge: Remove the device from the resident. Set the goniometer hinge as directed by healthcare personnel. Set the flexion and extension control and place the hinge into the outside lateral pockets of the device. The goniometer hinge may be set to control flexion and extension by opening the goniometer cover and positioning the secured pins.

To launder: Before washing, remove the hard goods. Machine wash on a gentle cycle and air-dry in the laundry bag.
