Definitions

The Direct Supply Panacea Short Opponens Orthosis with Soft Beads ("Device") is distributed by Direct Supply Manufacturing, Inc., referred to throughout this manual as "We," "Us" or "Our." "You" refers to the facility, community or other entity that has purchased the device.

Safety Notices – Warnings and Cautions

Read and follow all directions and warnings before using this device. Do not use this device without first reading and understanding this user manual. Damage, injury or even death may result from improper use of this device or not following directions and warnings. This device is intended for use by or under the supervision of trained and licensed healthcare or senior care providers in normal, indoor conditions.

WARNING: Immediately discontinue device use and contact appropriate healthcare personnel for further instructions if the device user experiences any of the following while using the device:

- Swelling
 Pain
- Skin Redness

MARNING: Device must be used with the soft cover.

WARNING: This device must only be applied by trained personnel.

WARNING: Refer to your facility's procedures regarding infection control.

A WARNING: Inspect the device for damage before each use and do not use if device appears to be damaged.

CAUTION: Do not place this device in an industrial washing machine or dryer.

Device Description

The Direct Supply[®] Panacea[®] Short Opponens Orthosis with Soft Beads (Model # DS-HSO) may be used for the treatment of severe finger contractures and may help prevent skin breakdown of the palm. The fabric covering may help wick away perspiration from the skin to prevent skin breakdown of the fingers and the palm. The easy hook-and-loop attachment of the soft straps secure the device around the wrist. This device also comes with an extra soft cover.

Directions for Use

To apply the device: First, open all of the hook-and-loop closures. Carefully open the patient's fingers and position the short opponens against the palm of the hand, then close fingers over the short opponens. The short opponens strap is adjustable and may be pulled left or right through the short opponens. Gently pull the strap (either side) through the short opponens until approximately 2/3 of the strap is exposed on one side of the short opponens. Wrap the strap around the wrist and fasten the hook-and-loop closure over the wrist. Check that it is secure but does not interfere with circulation. Pull the remaining strap over the hand and fasten the hook-and-loop closure to the wrist strap. Check that it is secure and does not interfere with circulation. Check the fit of the device on the resident periodically and more frequently over time. Your healthcare professional may provide a wearing schedule for your resident.

To launder: Separate the soft cover from the hand and wrist supports. On the soft cover, fasten all hook-and-loop closures, place in the provided laundry bag, and launder with a mild detergent at a low temperature. Afterwards, rinse thoroughly with cool water and let air dry or tumble dry at a low temperature.
