Definitions

The Direct Supply Panacea Hip and Knee Orthosis ("Device") is distributed by Direct Supply Manufacturing, Inc., referred to throughout this manual as "We," "Us" or "Our." "You" refers to the facility, community or other entity that has purchased the device.

Read and follow all directions and warnings before using this device. Do not use this device without first reading and understanding this user manual. Damage, injury or even death may result from improper use of this device or not following directions and warnings. This device is intended for use by or under the supervision of trained and licensed healthcare or senior care providers in normal, indoor conditions.

WARNING: Immediately discontinue device use and contact appropriate healthcare personnel for further instructions if the device user experiences any of the following while using the device:

Device Description

The Direct Supply Panacea Hip and Knee Orthosis (Model # DS-HKO) is designed for hip & knee flexion contractures with three abduction settings. This device can help treat hip adduction/abduction and knee scissoring, may increase range of motion, and may help reduce patient discomfort and pain due to the hip adduction/abduction and knee scissoring. The malleable cuffs allow for customized fitting with foam. The cuffs are covered with fabric that wicks away moisture from the skin to prevent maceration. The straps around the thighs are soft and comfortable. A mesh laundry bag is included.

Directions for Use

To apply orthosis: First obtain a desired range of motion and skin/wound care plan per a physician who is properly licensed in your state. The physician should determine the amount of abduction necessary as well as the intervals of time for treatment. Apply the orthosis by placing the horizontal member between the resident's legs and wrapping the wide straps around each leg, as seen in the picture at right. Assess the abduction, scissoring and skin integrity at each orthosis change. Immediately discontinue device use and contact appropriate healthcare personnel for further instructions if a resident has any adverse effect from this device.

To launder: Before washing, remove the hard goods. Machine wash on a gentle cycle and air-dry in the laundry bag.
